Documentation Required With Photo ID Licence Application

Licences will only be issued when the following documentation is received.

For All 2014 License Applications:

- Completed CASC license application form (Competitors **and** Officials)
- Proof of current membership in a CASC-affiliated club (eg. **Copy** of membership card)
- Completed "ASN Canada FIA Annual General Waiver" (may be electronically signed if sent by email), or completed "Annual Parental Consent Form" for Minor Applicants
- A high-resolution "head shot" or "passport-style" photo (may be uploaded to your personal record at "<http://dev.casc.on.ca/welcome.php>" or emailed to CASC, at "office@casc.on.ca")
- Appropriate fee, made payable to CASC Ontario Region

○ *For Road Race Competition Licenses Only, a completed CASC Medical Form as follows:*

- **All first time License Applicants must submit a medical**
- **Renewing License Applicants must submit a new medical**
 - Every 5 years between the ages of 15 and 35
 - Every 2 years between the ages of 36 and 59
 - Annually at 60 years of age

Note: Applicants should keep a copy of their completed medical form for their files

New Road Race applicants must also attach the following:

- Copy of racing school certificate, with Chief Instructor's endorsement (Note: Accredited Schools are only those professional and club racing driver schools recognized by CASC-OR and by ASN Canada FIA)
- Proof of age (eg. **Copy** of Birth Certificate, Driver's License, Age of Majority Card, Passport)

Digital Photo Requirements: Only Photo Licenses will be issued for 2014.

Your digital photo must be a "passport-style" photo with attention to the following:

- A minimum of 200 pixels wide x 280 pixels high (50mm x 70 mm, or 2" x 2.75"), 96 dpi
- Acceptable formats: jpg, tif, png
- Colour or black and white photo, taken straight on (facing camera)
- In focus (clear, sharp picture), with neutral facial expression
- Clear contrast between face and background, with plain, neutral background
- Uniform lighting: no shadows, glare, flash reflections
- Reflect your current appearance (taken recently, looks like you)
- Save Filename as: FirstName_Lastname.jpg (ie: John_Smith.jpg)

Applying for Your Official's Licence

Please remember to include the following documents with your official's licence application:

- Completed application form – signed and dated
- A copy of your previous CASC official's licence (if applicable)
- A photocopy of your validated log card from last year
- A photocopy of your current CASC-affiliated club membership card

Licence Upgrades

Send the completed application form, together with all the documents listed above, requesting the upgrade to the CASC office who in turn will contact the Regional Discipline Director for approval of the upgrade.

To avoid delays in the processing of your licence application, please be sure that all documents are enclosed and that the application is fully completed.

Minors

If the applicant is under the legal Age of Majority, a "Consent and Release by Parent or Guardian" form must accompany his/her licence application. These forms are available from the CASC OR office.

Marshal Licences

Please note that marshal licences are renewed through the marshal clubs (CRCA, MMS, MCO). Please forward marshal licence applications or renewals to your club.

In full or partial consideration for allowing me to participate in all related events and activities of the **EVENTS**, I hereby warrant and agree that:

1. I am familiar with and accept that there is the risk of serious injury and death in participation, whether as a competitor, student, official or worker, in all forms of motor sport and in particular in being allowed to enter, for any reason, any restricted area; and
2. I have satisfied myself and believe that I am physically, emotionally and mentally able to participate in **EVENTS**, and that my protective clothing, gear and equipment is fit and appropriate for my role as a participant in **EVENTS**; and
3. I understand that all applicable rules for participation must be followed, regardless of my role, and that at all times during the **EVENTS** the sole responsibility for my personal safety remains with me; and
4. I will immediately remove myself from participation, and notify the nearest official, if at any time I sense or observe any unusual hazard or unsafe condition or if I feel that I have experienced any deterioration in my physical, emotional or mental fitness, or that of my protective clothing, gear or equipment, for continued safe participation in the **EVENTS**.

I UNDERSTAND AND AGREE, ON BEHALF OF MYSELF, MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES AND NEXT OF KIN THAT MY EXECUTION OF THIS DOCUMENT CONSTITUTES:

5. AN UNQUALIFIED ASSUMPTION BY ME OF ALL RISKS associated with my participation in the **EVENT** even if arising from the negligence or gross negligence, including any compounding or aggravation of injuries caused by negligent rescue operations or procedures, of the Releasees, as that term is defined below, and any persons associated therewith or otherwise participating in the **EVENTS** in any capacity; and
6. A FULL AND FINAL RELEASE AND WAIVER OF LIABILITY AND ALL CLAIMS that I have, or may in the future have, against ASN Canada FIA, any person(s), entities or organization(s) associated in any way with the **EVENTS** including the track owners and lessees, promoters, sanctioning bodies, racing associations, or any subdivision thereof, track operators, sponsors, advertisers, car owners and other participants, rescue personnel, event inspectors, underwriters, consultants and others who give recommendations, directions or instructions or engage in risk evaluation and loss control activities, regarding the **EVENTS** or event premises, or any one or more of them and their respective directors, officers, employees, guides, contractors, agents and representatives (all of whom are collectively referred to as "the Releasees") from any and all liability for any loss, damage, injury or expense that I may suffer as a result of my use of or my presence at the event facilities or my participation in any part of, or my presence in any capacity at, the **EVENTS**, due to any cause whatsoever, INCLUDING NEGLIGENCE, GROSS NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE RELEVANT OCCUPIERS LIABILITY ACT ON THE PART OF THE RELEASEES.
7. AN AGREEMENT NOT TO SUE THE RELEASEES for any loss, injury, costs or damages of any form or type, howsoever caused or arising, and whether directly or indirectly from my participation in any aspect(s) of the **EVENTS**; and
8. AN AGREEMENT TO INDEMNIFY, and to SAVE and HOLD HARMLESS the RELEASEES, and each of them, from any litigation expense, legal fees, liability, damage, award or cost, of any form or type whatsoever, they may incur due to any claim made against them or any one of them by me or on my behalf, or that of my estate, whether the claim is based on the negligence or the gross negligence of the Releasees or otherwise as stated above.
9. AN AGREEMENT that this document be governed by the laws, and in the courts, of the Province in which the **EVENTS** occur.
