Race organizer did not include stewards in officials list or in radio allocation - rectified at track immediately by Clerk of the Course

Not a good start to the weekend - Stewards located off-track, in lower paddock with no easy access to tower, drivers or track and in an area difficult for drivers etc to find, let alone access. No internet access arranged, no parking for stewards arranged. Track administration informed of

unacceptability of location and lack of services - complaint to Clerk of the Course resulted immediately in internet access, radio, 1 parking spot and ultimately a move to the actual event venue at 12:45 p.m. Track administration subsequently more supportive re necessary location and services/support.

Tech issues - no tech stickers available and annual inspection book not available

Pit official impounding cars in pit lane during qualifying race - direction given by Clerk of the Course who subsequently recognized his error and re-directed officials to let cars leave the pits at any time during qualifying sessions

No decals available at track for Pirelli challenge until Sunday afternoon

Pirelli Challenge continues to be the subject of driver confusion as decals and information not available at the track to determine eligibility in the absence of decals. Timing and Scoring aware and times for the race on Sunday will not be finalized until all entries can be scrutinized for eligibility for points and positioning.
