Promotions:

- we made Inside Track our Media Partner for 2022, subscriptions to everyone in the CASC members active database
- Full page ads in most issues, we followed a plan to promote the different Divisions over the course of the year, Ice Racing is our Dec focus
- Will renew for 2023
- Goal is a planned approach to our media coverage
- Participated in Motorama and Drive Fest in 2022
- Plan in 2023 is appoint a Promotional Event Planner to co-ordinate displays at Motorama, 3 major car events at CTMP, Indy, and Drive Fest
- Goal is to attract both competitors and volunteers

• Licensing:

- Plan is to reduce time and effort spent on issuing license as much as possible
- Multi-year licensing for competitors and volunteers
- Automated as much as possible
- Reduce licensing fees
- Eliminate hard cards, they will be available for purchase for those that really want them



6. Preliminary Financial Information
