Supplemental Rules as of August 5, 2020

Held under CASC-OR General Competition Rules, Race Regulations and these Supplemental Regulations.

CASC-OR Permit Non. RR-03

1. Races will be held for the following CASC-OR classes; Formula Libre, Toyo Tires Formula 1600, Pirelli GT Sprints (GT1/2/3/4/5), Vintage/Historic/F1200 and Classic. There will also be two championship rounds of CTCC presented by Pirelli.
2. The event is sanctioned by CASC-OR and organized/promoted by Shannonville Motorsport Park Inc.
3. Paddock move-in is permitted beginning Thursday August 13, 2020 at 6:00pm.
4. The main entrance gate will be locked at 9:00pm each evening and reopening at 7:00am.
5. Test-day registration will be at the Shannonville Registration Centre; cost is \$300.00 plus HST totalling \$339.00.
6. Test-day and event registration cheques shall be payable to Shannonville Motorsport Park Inc.
7. CASC-OR participants may register for the event using MotorsportReg.com.
8. On-site event registration will be held Friday August 14, 2020 from 12:00pm to 8:00pm and Saturday August 15, 2020 from 6:30am to 10:00am in the Shannonville Registration Centre.
- 9. Drivers' Meeting for CASC-OR competitors will be held on Saturday August 15, 2020 at 7:45am in the Main Grandstand.**
10. Insurance for this event will be provided by Stoneridge Speciality Insurance.
11. Shannonville Motorsport Park Inc. reserves the right to change the official schedule with respect to order, the length and or groupings of any session.
12. Any competitor needing to see a Clerk may ask any official with a radio to contact the Clerk for directions to arrange a meeting.
13. Race Medical is located in the Main Administrative Building.
14. Technical Inspection will be at the CASC-OR trailer located in the paddock.
15. Any time there is to be a transfer of fuel there must be a separate designated person standing, holding an appropriate fire extinguisher. This person's sole responsibility is to watch for and be prepared to react to a fire. Refuelling must not be done under an awning or in a place where fumes may accumulate or a person may become trapped.
16. All persons who wish to enter a restricted area must sign the Insurance waiver and wear the appropriate wristband as issued by the promoter. Waivers for minors under the age of 18 are available at registration and must be signed by a parent or legal guardian. For purposes of this

event restricted areas are: i. Pit lane ii. Pit boxes iii. Mock Grid iv. Track side as defined by existing spectator fences.

17. Mock Grid will be located directly behind the Main Grandstand.
18. All races shall be rolling starts.
19. Be aware that emergency and service vehicles may be dispatched during all cool down laps and/or onto the "hot" track at any time and from any location without a race stoppage or without a full course caution.
20. Notices and Results will be posted near the east end paddock washrooms.
21. Trophies will be awarded after the race group's final session on Sunday at the podium located directly behind the Main Grandstand.
22. Spectator admission is \$20.00 for the event, maximum 100.
23. Shannonville Motorsport Park Inc has the right to refuse an entry without a statement or reason for refusal. If an entry for any competition is refused, notification shall be sent or transmitted to the Entrant as soon as possible.
24. All participants shall adhere to the COVID-19 guidelines posted on the Shannonville Motorsport Park website.
