**CASC-OR RACE REGULATIONS 2019 v1.2
Dated July 11, 2019**

1) Race Regulations

Section 3.1.3 DISPLAY OF CASC-OR LOGO ON COMPETING VEHICLES

New section 3.1.3:

All vehicles competing in a CASC-OR sanctioned event shall display a CASC-OR logo in a position clearly visible in a front three quarter view of the vehicle. Additional logos and/or positions may be required by subsequent rules and regulations.

2) Appendix 'H' – Flags and Light Signals and Rules of the Road

Section 3.5 BLACK AND WHITE FLAG

The warning flag for unsportsmanlike driving behaviour must be displayed at the start/finish line, and may be displayed in another location.




Replace 3.5 with:

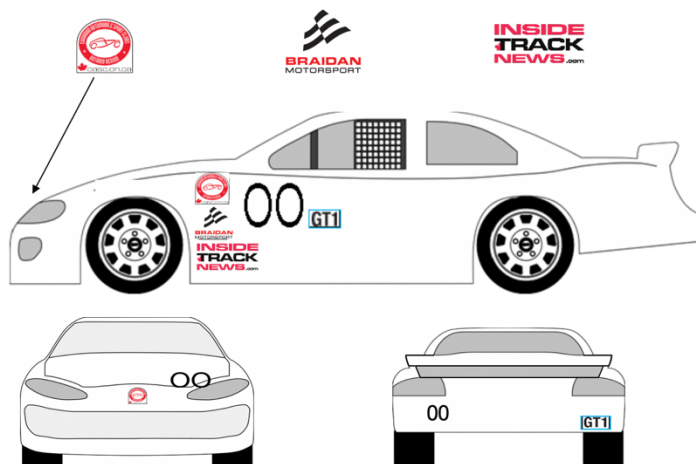
Divided diagonally into black and white halves, shown motionless at the start/finish line **and** other location **if** specified in the Supplementary Regulations, and accompanied by a number on a board, it informs the Driver of the Car designated by the number that his/her conduct or driving has been observed as being unsporting or unsafe. It is a warning; if the behavior continues the Driver may be shown the Black Flag.

Section 4.2.1 GT Sprints, GT Challenge, and VARAC

New Section 4.2.1 indicates the mandatory placement for CASC-OR sponsor decals. Note: VARAC period livery correct cars are exempt.

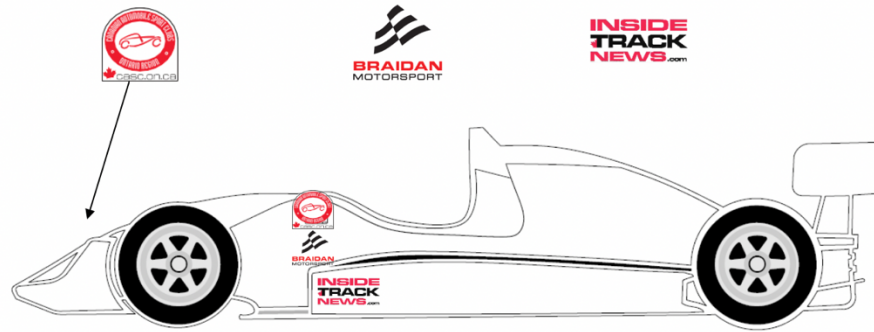

New Section 4.2.2 indicates the mandatory placement for CASC-OR sponsor decals.

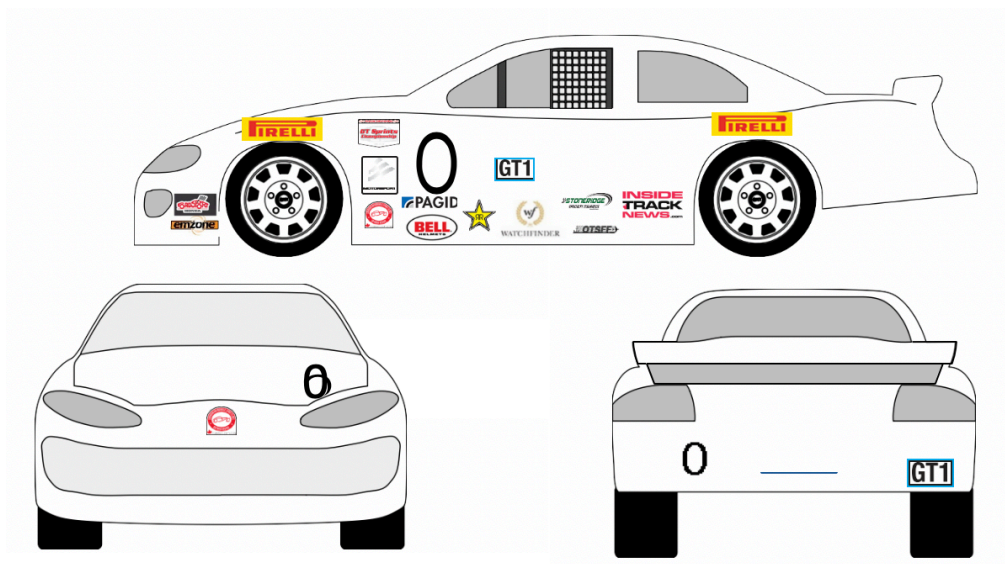

Section 8.1.3 PIRELLI Tire GT Challenge & Touring Challenge Series Points

Corrected reference to points section.

Replace 8.1.3 with:

All classes will be scored following Section 7.2.3. If multiple races are scheduled for the same event, they will be counted as separate races.

7) Appendix 'P' – Race Ontario Series Regulations

Section 8.1.6 PIRELLI Tire GT Challenge & Touring Challenge Series Points

To align the finishing percentage with Race Regulations Section 2.3.12.

Replace 8.1.6 with:

To qualify as a finisher, a competing car shall have completed *50% of class winner's distance (rounded up)*.

8) Appendix 'P' – Race Ontario Series Regulations

Section 5.1.1 Car Classes

A minor change in the wording of Formula Libre.

Replace 5.1.1 h) with:

Formula Libre: Formula 4, *and* Formula cars not listed above plus any formula *or Radical Cup cars* listed above choosing to participate in this class.
